By sending/submitting the application forms, you allow Department 3, Section 3.3 to collect, store and use the personal data for the application procedure and the implementation of the measures. This includes disclosure of personal information within the university as well as to other institutions that are involved in the implementation of the measures. The following data will be collected and stored in the context of your application:

- First name, Surname
- Date of birth
- Sex
- Nationality
- Home address
- Email address
- Home university
- Program/Name of scholarship
- Intended study program
- Intended date of arrival
- Rental period.

The above mentioned data is mandatory.

On condition of your consent, the legal basis for the processing of data is Art. 6 para. 1 lit. a GDPR. The legal basis for the processing of data in order to fulfil a contract or implement pre-contractual measures which take place on request of the data subject is Art. 6 para. 1 lit. b GDPR.

By submitting the application forms, you agree to storage and use of your personal data for the above mentioned purpose. The provided data will be used for the application procedure and the implementation of the measures only. If you decide not to fill in the application forms, the relevant measures cannot be implemented.

We take the protection of your personal information very seriously. You have the right to free access to your stored personal data, its origin, recipient and purpose of the data processing and, if applicable, to correction, blocking or deletion of the data within the scope of the applicable legal regulations at any time. After completion of the studies, your personal data will be deleted after the legal archiving periods have expired.

Apartment und 2er-WG
